Notice:

1. Refrain from repeated inquiries with no relevant basis from the university or other authorities.
2. To listen to more explanations and guidance, you can meet with the liaison of the Admission Council on 3 Aban 1362 [25 October 1983] from 15:00 to 15:30 at the University of Isfahan, Faculty of Science, at the end of the corridor of the Physics Group.
3. If you intend to appeal to the [aforementioned] decision, you can mail your appeal application, together with the documentation, if any, indicating your exact address, and telephone number if applicable, so that you could be immediately contacted in the necessary case, [no later than] the date of 6 Aban 1362 [28 October 1983] by registered mail to the Admission Council at the following address: Isfahan, University of Isfahan, P.O. Box 33, Admission Council of the University of Isfahan; or present it directly to the Faculty of Science of the University of Isfahan, at the end of the corridor of the Physics Group, the liaison of the Admission Council, and take your receipt.
4. Appeals lacking the exact address of the appellant student will not be considered.
5. In the case of your appeal, the Admission Council will issue a new revised decision, only by 25 Aban 1362 [16 November 1983] which will be sent to you, or you can inquire on 28 Aban 1362 [19 November 1983] at the Faculty of Science of the University of Isfahan, at the end of the corridor of the Physics Group, [where,] by presenting your receipt, you can receive the revised decision from the liaison of the Council of Acceptance.
