If you contest the issued ruling, you can send your appeal with potential documents and evidence by registered mail to the Admissions Council no later than 29 Shahrivar 1362 [20 September 1983] at the following address: Shiraz – Management Department, Room 209, School of Medicine, Shiraz University. Please include your exact address and, if possible, a telephone number where you may be contacted immediately, if necessary.

Or deliver to the Admissions Council liaison at the School of Engineering and get a receipt

4. Appeals which do not include the exact address of the contesting student will not be considered.
5. If you appeal, the Admissions Council will issue an appeal ruling about you no later than 10 days after receiving the appeal, which will be sent to you. Or you can go to the School of Engineering at the above date and receive the appeal ruling after providing the receipt.
